PROCARE AMBULANCE OF MARYLAND, INC. TO PROVIDE AMBULANCE TRANSPORTATION FOR PRINCE GEORGE'S COUNTY MEDICAL ASSISTANCE RECIPIENTS

BALTIMORE, MD – August 21, 2012 – Procare Ambulance of Maryland, Inc., a full-service commercial ambulance and wheelchair van transportation company, is pleased to announce that it was awarded the Prince George's County Medical Assistance contract to provide non-emergency Basic Life Support, Advanced Life Support and Critical Care Life Support Ambulance Transportation services to eligible Prince George's County Medical Assistance patients.

Procare will provide ambulance transportation for patients who are non-ambulatory and, due to their condition, require ambulance transportation services from their residence or medical facility to their residence or medical facility. Eligibility under the program is determined by the Department of Health, who must approve all transport requests. The program is estimated to service over 2,000 patients.

The contract award is the result of a multi-step, year-long bidding process that included a comprehensive Bid Response reviewing Procare's project approach, staffing, quality control, experience, references and training and development programs. The contract went into effect on August 1, 2012 and upon its one-year contract expiration date, it can be extended through mutual agreement of the parties for three additional one-year periods.
